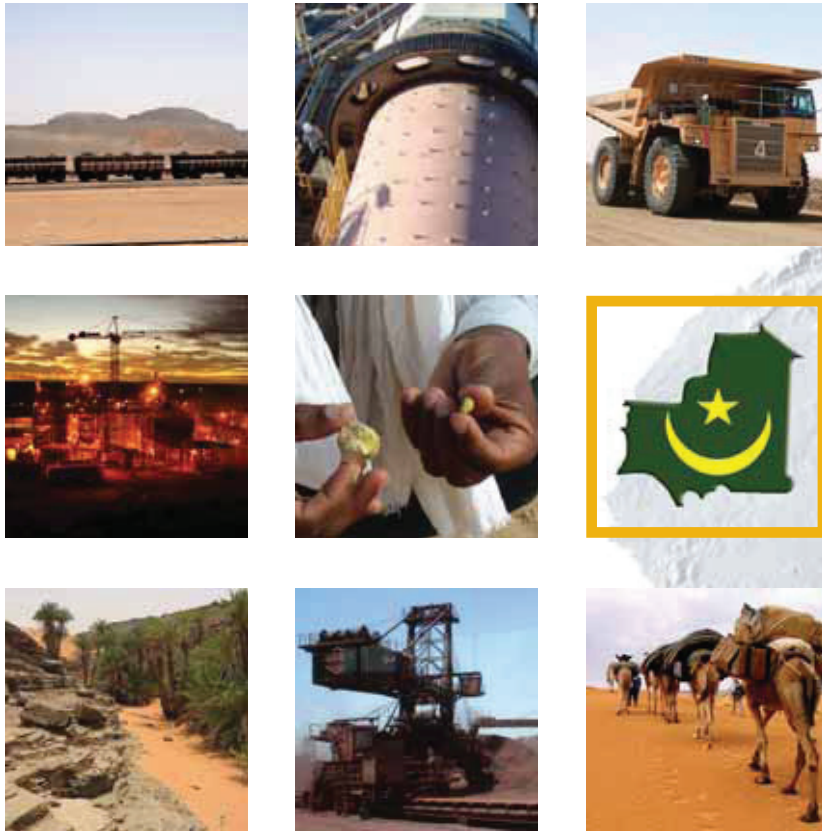

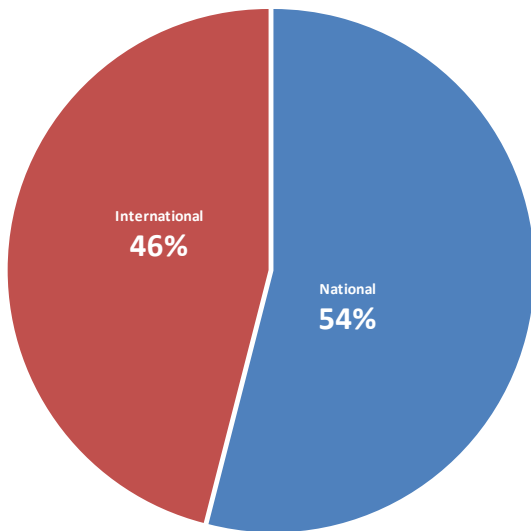

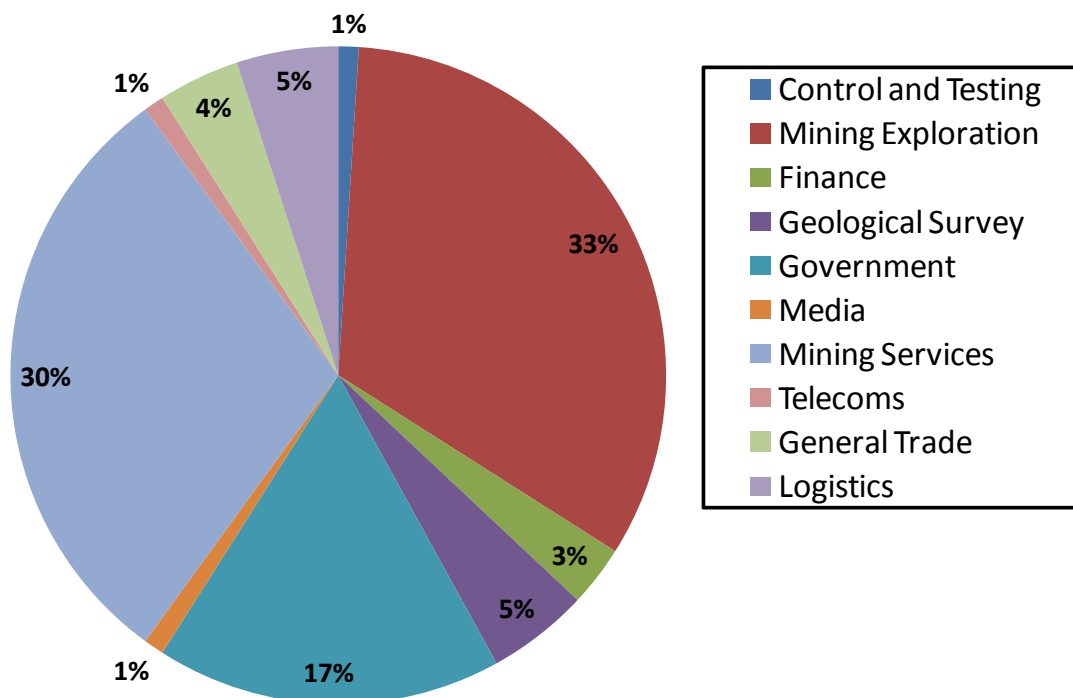


International Participation

Overview of the Event

MAURITANIDES 2010, 1st Mauritanian Mining Conference and Exhibition was organised at the Palais de Congres, Nouakchott from 9 – 11 November 2010. The event was co-organised by Ministry of Industry and Mines, Mauritania and the English consultancy, AME Trade Ltd under the Presidency of the President of the Republic, His Excellency Mr Mohamed Ould Abdel Aziz, under the theme “Mauritania, the hidden treasure of the desert”.

In his opening speech, the President of the Republic, His Excellency Mr Mohamed Ould Abdel Aziz, detailed that the Mauritanian government is constantly pursuing their actions to improve the legal and regulatory framework of the mining sector to make it more attractive to investors.

He commented that the revision of the mining code and its texts of application recently has allowed them to adopt essential reforms which reinforce transparency, simplify the process of attributing mining permits and clarify the fiscal regime and others. He also added that the mining sector has received promising perspectives as a support of this fact he commented that “the constant influx into the country of the actors was measured by the presence of them today in Nouakchott and demonstrates the actual intense activity in geological prospection which comprises of over 50 mining companies (of which are included large multinationals) who operating on 170 mining permits”, he also underlined that the results of this exploration work was most encouraging.

1. The Investment Climate in Mauritania:

This theme was developed through three speeches, the mining legal framework, fiscal mining framework in Mauritania, and the investment climate in Mauritania. During the session the speakers commented on the favourable investment climate in Mauritania created by the Government in view of giving advantage to and attracting notably mining investors to Mauritania. These favourable terms are illustrated by the constant adapting of the mining legal framework in the context of the evolution of mining industry and taking into account the regional and international frameworks. Also the reforms were recently adopted in view of reinforcing transparency, the simplification of procedures to attribute mining titles and the clarification of the fiscal and customs mining regime.

2. Mining opportunities in Mauritania:

This theme was covered by 4 speakers who covered the following aspects. The Place and role of SNIM in the development of the mining activities, the development of the geological infrastructure, the new edition of the geological map to the scale of 1/1.000.000 and mining opportunities in Mauritania.

During these speeches, the importance of the availability of geological information was stressed thereby permitting investors to have an overview of the geological and mining potential that the country possesses. It is the responsibility generally for the Government to put in place adequate infrastructure to stimulate mining exploration. In the case of Mauritania, their development partners and they have put in place a geological infrastructure which conforms to:

- A geodesic network
- Relatively detailed geological mapping
- Aero geophysical coverage
- A Geological and Mining information system

The Government is constantly pursuing its efforts to improve this infrastructure in view of better knowledge of the country's mining potential and the investment opportunities that can be offered. The national sub-soil already contains going on the number of indices discovered (900), important minerals and mines. Mauritania has a strong geological and mining potential based on its attractive legal framework and is considered today as a very attractive destination for mining investors.

The historical role of SNIM was explained, in particular as a major economic player, which contributes a very large amount to the development of the national economy notably with its support to:

- ▶ 10% ⇨ of GDP,
- ▶ 40% ⇨ of Exports,
- ▶ 20% ⇨ the State budget.

With an experience of more than 50 years, SNIM today masters the complete operations chain relating to mining: extraction, manutention, enrichment, rail transport, the port, production of water and electricity, maintenance, commercialisation and trading. SNIM is today orientated towards the exploration for substances including iron and others in the framework of a policy of diversification which is knocks on the service companies which are affiliated to them.

3. Developing Mauritania's copper potential:

This session was dedicated essentially to the theme relative to copper in the Northern part of the Mauritanides chain, with the example of the Guelb Moghrein deposit of Akjoujt. The mineralisation of this deposit is of the type "IOCG". It is encased in ferromagnesians localised in a shear zone associated with a structurally complex framework. The company MCM has effected intense exploration work close to the mine to find supplementary reserves to prolong the mine's life and activity. The compilation of the results of the exploration has permitted MCM to define zones which are considered to be promising. It should also be noted that several indices of copper has been reported in different zones of the Mauritanides chain, notably in the permit zone of Shield Mining in Saboussiri.

4. Gold perspectives in Mauritania

During this session 4 speeches were presented. They covered the following themes: gold exploration activities in Mauritania with the example of the company Gryphon Minerals, the perspectives of gold in West Africa and the gold potential in Mauritania



Several companies are engaged presently in gold exploration on the national territory of in particular Tasiast Mauritania Ltd, the company MCM, Gryphon Minerals as well as others. The results of these studies altogether are very encouraging and mean that many companies are renewing their permits. For example, the research activity of TML SA has thrown up some remarkable results permitting the company to multiply its reserves by 10 or 20 times. The company MCM are pursuing with interest the research in their different permits which seems to show major results, notably in Kdeillat Lejoul. It should also be pointed out that the JV of Gryphon and Shield Mining has realised some important exploration work on their permits in particular in Tijirit.

5. Iron Ore Perspectives in Mauritania

The known Ferruginous formations are actually situated in the geological formation of the Dorsale R'Gueibat. This formation covers a good part of the North of the country with some extensions to the South West (Tasiast, Tijirit, Amsaga). The dorsal consists of very ancient formations (archean and Birimian). Deposits of iron and salt are also exploited as well as gold in Tasiast. There are several mining exploration program actually in existence at the moment.

Other important quantities of iron have been put in evidence by certain exploration companies notably:

- Sphère at Askaf and Lebtheinia ;
- Wadi Rawda Industrial Investments at Imkebden and Tiverchai,
- Bumi Mauritania at Tamagot and Sfariat,
- SOMASO at Kawa El Hkadra...etc.

SNIM predicts in the framework of it is PDM and with its partnership with Sphere, Mines Metal and Arcelor, the increase of production to attain 18 millions tonnes by the horizon of 2014. Also it was also announced the takeover of the Askaf deposit from the company Sphere by the giant Xstrata who plans to profit from its financial capabilities and its technical competences launch its activities.



6. Uranium Exploration

The exploration for uranium in Mauritania started essentially in 2007 in R'Gueibat dorsal. The exploration activities have been initiated by foreign companies such as Forte Energy (JV between Murchison and Areva), Aura Energy, Gazal Minerals and national companies such as Macoba-TP and BSA. Through exploration promising indices and prospects for uranium have been discovered in the Northern calcretes. Drilling programs are envisage in 2011 to evaluate the resources.

7. The promotional zone of Sfariat

The promotional zone of Sfariat is 5000km² and comes from the birimian age of gold in Africa. The area has been the object of intensive research carried out by OMRG, which has uncovered some interesting indices of gold. This zone has just been the subject of a tender bid.

8. Sustainable and Community Development related to mining activities in Mauritania.

Sustainable development is « a development which responds to the needs of the present generations without comprising the capacity of future generations to respond to their needs »
This definition puts very much the accent on equity amongst generations.

Mining exploitation is by nature non sustainable, mineral resources are non renewable. However, it can have certain sustainability if it is connected to other sectors of the economy. The socio-economic benefits of the sector must be optimised by a rational utilisation of the sectors revenues to catalyse a larger development, guaranteeing total integration of the sector with the rest of the national economy and to limit as best as possible the negative impacts caused by mining exploitation on the environment.

Being conscious of the importance of protecting the environment, Africa has already its Mining Vision 2050 adopted by the African Union in February 2009, with the theme being " transparent, equitable and optimal extraction of mineral resources, with the aim of sustainable growth and a general socio-economical development" Mauritania adheres totally to this vision.

The profits from mining activities must contribute efficiently to the blossoming of communities living in harmony with the mining activities and by the necessary indispensable services such as:

- Water and Electricity
- Sanitary infrastructures and education
- Roads
- Finance of small businesses ;
- Sports Equipment.

This event was co organised by the Ministry of Industry and Mines and the consultancy AME Trade was sponsored by exploration and mining service companies.

400 delegates and more than 1000 participants representing 30 countries participated in this important event. On this occasion 49 stands were occupied by the mining operators and mining service companies.
